Davis Commodities, LLC. Credit sales are due and payable in full by the due date according to the terms of sale specified on the invoice. No terms or conditions of sale different from R.A. Davis Commodities, LLC terms of sale will become part of any agreement unless approved in writing by R.A. Davis Commodities, LLC.
- 2 A finance charge of 1 1/2 percent per month (18.0% per annum) or the highest amount permitted by law may be assessed against outstanding account balances. For those accounts, which incur finance charges, payments or credits may be applied first to finance charges and then to outstanding invoice balances at the discretion of R.A. Davis Commodities, LLC.
- 3 Accounts that are 60 days past due may be changed to COD until the account is brought current.
- 4 Customer agrees to pay all legal expenses, including court costs and attorneys fees, incurred in collection of all past due invoices and other balances on the account.
- 5 R.A. Davis Commodities, LLC has the right to reduce the Credit Limit and/or withdraw Customer credit under this Agreements at any time without prior notice, except as otherwise provided by law.
